**Updates:**

- The Town Board voted to not approve the Sweet Road solar overlay district at their September 6 meeting.
- Onondaga County is updating the county comprehensive plan and is seeking public input. This is an opportunity to ensure concerns and issues of importance to Pompey are reflected in long term county plans.
- Kathleen Bertuch provided written summary notes on the “Locally Sourced Municipal Green Policy Solutions” conference that she attended at ESF on September 9, 2022. A link to the conference proceedings will be forwarded to ECC members when it is available.
- Kathleen Bertuch met with Renee Rotundo on September 12, 2022 to discuss Town policies and logistics associated with public education and outreach efforts being discussed by the ECC.

- Stan Gorman is working with Renee Rotundo and Tim Frateschi to review past efforts undertaken, and next steps required to identify the owners of existing cell, radio and television towers on Sevier Rd. Issues of concern for the Town include accurate tax assessments and ongoing maintenance of an unused tower and support building.
