CODE OFFICER'S REPORT:

R-81-25 Motion by Loomis, seconded by Angello to approve the May 2025 Code's Officer Report. All in favor. Motion carried.

HIGHWAY SUPERINTENDENT'S REPORT

Highway Superintendent Bruce Way stated that they are prepping roads to be oil and stoned. The Highway Department has been doing a lot of ditching, mowing roadsides, and culvert changing. Onondaga County had more grant money available, so the Highway Department was able to purchase two new blades for snowplowing.

DEC GRANTS:

Community Forestry Educator Leanna Nugent from Cornell Cooperative Extension of Onondaga County appeared before the Town Board to discuss the Tree City USA program, which is one of Arbor Day Foundations oldest initiatives. There are four criteria the town would need to meet in order to become a Tree City USA. There is grant money available if the town decides to pursue joining the program.

COUNCILORS REPORT:

Councilor Carpenter gave an update on the Town's Facebook page; it is still a work in progress. Bob Rugio is making sure that the current platform is the way to go.

SUPERVISOR'S REPORT:

Deputy Supervisor Tom Henry gave an update on the Main Street Beautification Grant, Pompey Club finally received the windows they had been waiting for. They should be reimbursed within the next few weeks.

Deputy Supervisor Tom Henry gave an update on the SAM Grant; there was \$67,000.00 left. He and Highway Superintendent Bruce Way have been working with Town Engineer John Dunkle to install an Oil and Water Separator for the shop which is approximately \$65,000.00. Highway Superintendent Bruce Way is working on getting bids and hopefully this project will be completed before the winter arrives.

Deputy Supervisor Tom Henry gave an update on the NYSERDA Grant. John Shaheen was able to secure the grant in the amount of \$60,000.00 which will be used to reinsulate the east wing of the Highway Garage which is badly needed. Bids will be put out for that project very soon.

WHEREAS, the Central New York Regional Planning & Development Board (the "Board") has provided program planning and implementation assistance pertaining to the requirements of the New York State Pollutant Discharge Elimination System (SPDES)

Phase II General Permit for Municipal Separate Storm Sewer System (MS4) operators since 2002

(the "Assistance Services"); and

WHEREAS, the Board has proposed staff and education assistance services in support of sustaining the CNY Stormwater Coalition and to provide a regional public education, outreach and training compliance program to reduce municipal staff burdens, ensure consistency,

provide widespread priority audience targeting the most efficient use of limited municipal funds by distributing total program costs over a number of entities within a twelve-month timeframe (the

"Education Services", and, together with the Assistance Services, the "Services"); and WHEREAS, the Town Board desires to authorize the Town to pursue (i) certain assistance services offered by the Central New York Regional Planning & Development Board pertaining to the requirements of the New York State Pollutant Discharge Elimination System (SPDES) Stormwater Phase II General Permit for Municipal Separate Storm Sewer System (MS4)

operators, and (ii) certain education assistance services sustaining the CNY Stormwater Coalition

in an effort to reduce municipal staff burdens and ensure consistency; and **WHEREAS**, the Town Board desires to authorize the Acting Town Supervisor to enter into an Intermunicipal Agreement with Onondaga County to assist the Town in complying with its general obligations as an MS4 operator, subject to final legal review.

NOW, THEREFORE, be it

RESOLVED AND ORDERED, that the Town Supervisor or such person's successor in office is the representative authorized to act on behalf of the Town's governing body

in all matters related to obtaining and receiving the Services;

RESOLVED AND ORDERED, that the Town agrees that it will fund its portion of the program cost in the amount of \$3,600, and that those funds will be made available to the Board upon receipt of invoice;

RESOLVED AND ORDERED, that the Acting Town Supervisor or such person's successor in office is authorized to enter into an Intermunicipal Agreement with Onondaga County

to assist the Town in complying with its permit obligations as an MS4 operator, and, such other documents as may be necessary to effectuate the Intermunicipal Agreement, all being subject to final legal review, and

BE IT FURTHER RESOLVED AND ORDERED, that this Resolution shall take effect immediately.
