The Town Board of the Town of Pompey held its Regular Meeting on Tuesday, February 13, 2024 at 6:30 p.m. The meeting was held in-person and was also live-streamed via Zoom platform. Supervisor Nardella called the meeting to order at 6:30 p.m. followed by the Pledge of Allegiance.

PUBLIC COMMENT:

Deborah Grenier, Cemetery Road: Is the Deputy Town Clerk position new? Is it part-time or full-time? Were Town Residents given notice and able to apply? Alma Hartnett was already appointed as an assistant to a different town official last month. Town Attorney David Capriotti responded that the Town Clerk can appoint her own Deputy with no requirement to canvas and Alma can retain both positions.

HIGHWAY SUPERINTENDENT'S REPORT:

Highway Superintendent Way gave an update that the Mac truck has arrived. It is currently in Watertown waiting for a bay at Henderson to get all of the plow equipment on it. They've been waiting a year and a half.

SUPERVISOR'S REPORT

Supervisor Nardella gave an update on the mugs and tumblers that were purchased by the Town of Pompey to support a fundraiser for the Pompey Historical Society. The Town purchased them back in July 2021 in hopes of selling them for \$11.00 each. The Historical Society was planning on selling them and reimbursing the town for the cost. The mugs and tumblers have not been big sellers and the storage room in the Town Hall is full of merchandise. As of January 2024, there are approximately 250 mugs (cost of each is \$5.88) and approximately 160 tumblers (cost of each is \$3.89). Both the mugs and tumblers are now being sold at The Pompey Mall and Heritage Hill for \$1.00 each.
