RESOLUTION GRANTING AUTHORIZATION TO SUBMIT REQUEST FOR FUNDING

The TOWN BOARD OF THE TOWN OF POMPEY, in the County of Onondaga, State of New York, met in special session at the Town Hall in the Town of Pompey located at 8354 U.S. Route 20, Manlius, NY 13104 County of Onondaga, State of New York, on the 30th day of October, 2023, at 6:30 p.m. This session was also livestreamed on the interactive platform commonly referred to as Zoom and on Facebook.

The following resolution was moved, seconded and adopted:

WHEREAS, the Town of Pompey believes that the safety of its residents and the Town Court personnel is of the utmost importance;

WHEREAS, the Town desires to apply to the Justice Court Assistance Program (JCAP) for the purpose of obtaining funds to make repairs and/or improvements to the courtroom and courtroom building and to purchase security items and/or furniture, which repairs, improvements and/or purchases are recommended by the Town's two Justices;

WHEREAS, the Town of Pompey Justice Court lacks sufficient space to store its court records and is furnished with 30-year old seating, necessitating additional storage space (shelving) and new furniture for the court room (chairs and a lectern);

WHEREAS, the Town Board agrees that the modifications as recommended by the Town Justices should be implemented upon obtaining grant moneys through JCAP;

NOW, THEREFORE, be it

RESOLVED AND ORDERED, that the Town Board hereby authorizes the Town of Pompey Town Court to apply for a JCAP grant in the 2023-24 grant cycle for up to the sum of \$30,000.00 from the Justice Court Assistance Program for improvements to the courtroom and courtroom building; and be it

FURTHER RESOLVED, that the Town of Pompey Justice Court and the Town Supervisor are authorized to take any and all measures necessary to make this application to, and accept the funding from, JCAP; and be it

FURTHER RESOLVED, that this Resolution revises and supercedes the Resolution passed by the Town Board on September 12, 2023.
